Announcement on Start of Redemption of Loans Related to Special Loans, such as Emergency Small Amount Fund Emergency Small Amount Fund

The first date of redemption (deadline for payment) of emergency small amount fund is January 31, 2023.

[Redemption by account transfer]

Please make redemption (payment) by account transfer (automatic withdrawal), in principle. Please fill in the Account Transfer Request Form (Automatic Payment Application Form) and put a seal registered to the bank on the form before sending (returning) it with the enclosed reply envelope.

In the case that the form is sent or (returned) by **November 30, 2022 (Wednesday)**, the withdrawal will be made from January 27, 2023, (Friday) when there are no deficiencies in the form.

Please be sure to confirm the balance of the account by a day before the withdrawal to avoid a shortage in the balance on the transfer date when the redemption is made by account transfer. The withdrawal will be made on the 27th of every month (the following business day when the 27th falls on a Saturday, Sunday, or holiday)

If an account transfer fails, you are required to make the payment for the relevant month by payment handling slip. In that case, please contact the following point of contact.

[Redemption by payment handling slip]

In the case that you make the redemption by payment handling slip, please make payment by the given payment handling slip from the nearest branch of THE HOKURIKU BANK, THE FIRST BANK OF TOYAMA, or the Japan Post Bank by the redemption date.
